Programming & Production: TPT produces and acquires television programming for local and national audiences. In 2014, we broadcast more than 35,000 hours of programming to local audiences through our four over-the-air broadcast television channels, and nearly 9,000 hours of programming to audiences across Minnesota (but outside our metro area) via our statewide Minnesota Channel. We produced more than 175 original programs, including the longest running local television in the Twin Cities ("Almanac"), a weekly arts and cultural affairs program ("Minnesota Original"), a new Minnesota music performance series ("The Lowertown Line"), 123 projects produced with local partners focused on issues of local and regional importance, several documentaries, a series of films produced for PBS and broadcast across the United States including "Justin Hayward: Sprints Live", and "Kevin Kling: Lost and Found", and our ongoing "SciGirls" series for PBS, focused on young people interested in science, technology, engineering and math.

Broadcasting: TPT originates four over-the-air broadcast television channels to local audiences. TPT 2 is our flagship service, featuring the best PBS programming along with additional programs produced or acquired by TPT. TPT Life showcases the best of lifestyle and current affairs programs. TPTMN is the home of "The Minnesota Channel": A 24 hour per day channel that provides 945 hours of coverage of the Minnesota state legislature, along with over 7,700 hours of programming about the state, its people, heritage and cultures. This channel is distributed throughout the state of Minnesota in conjunction with the Minnesota Public Television Association, an organization representing all of the state's public broadcasting outlets. Finally, TPTWX serves families in the Twin Cities as a free, 24 hour per day weather channel.

Program Information: Twin Cities Public Television operates a series of web sites that were visited in 2015 more than 20.8 million times and generated approximately 43.7 million page views. TPT also maintains an extensive online collection of local television programs and video segments. At last count, approximately 3,200 programs representing roughly 2,750 hours of TPT video content are available through TPT's interactive portals.
